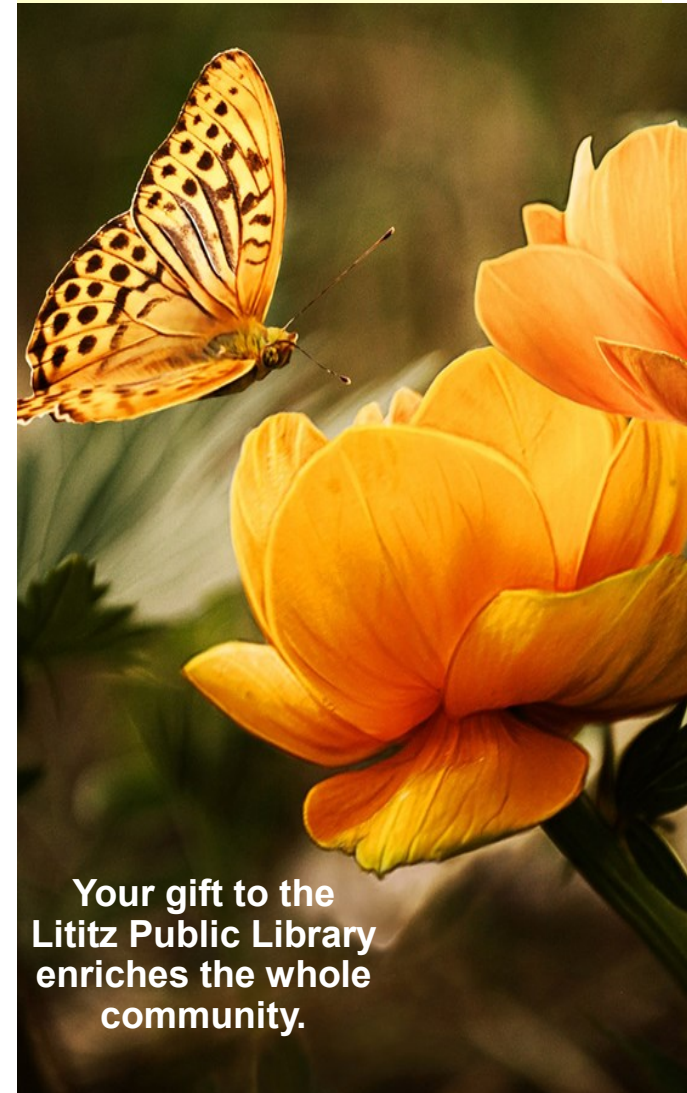

The Lititz Public Library has been fortunate to receive generous support from farsighted individuals who made contributions through their Wills, often at a more significant level than they could have made with an outright donation.

*A bequest is a legacy that enriches future generations.*



Supporters can make a charitable gift by naming the Lititz Public Library as a beneficiary in their Will. Your Will can include gifts in the form of property, a percentage of your estate or the residue of your estate (property remaining after other bequests have been fulfilled).

*Although only a few sentences are needed to make a bequest in your Will, it is recommended that benefactors consult with a lawyer to prepare the Will or Codicil.*

If you wish to make a bequest to the library, we suggest the following wording:

*I give, devise and bequeath [\$ fixed amount or percentage] to the Lititz Public Library, Inc., a Pennsylvania non-profit corporation (EIN 23-6406263) located in Lititz, Pennsylvania 17543.*
